

Terms of Service

The <https://miveratech.com> (and <https://beta.miveratech.com>) referred to henceforth as the "Site", is comprised of various web pages operated by Mivera Technologies Inc. ("Mivera"). The "Site" is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of the "Site" constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

Mivera is a platform that enables families to connect over wellness and allows the user to schedule and send wellness check ins, reminders, and question prompts using SMS and other messaging services.

Privacy and Preferences

Your use of the "Site" is subject to Mivera's Privacy Policy. Please review our Privacy Policy, which also governs the "Site" and informs users of our data collection practices. By using Mivera, you acknowledge that you have read the Privacy Policy, which explains how we handle members' and visitors' personal information.

The provision of personalized content is essential to the provision of our Services and a core part of our agreement with you. By default, you will receive notifications from Mivera for any requests to you from your circle members.

If you use this site, you are responsible for maintaining the confidentiality of your account and password, and you agree to accept responsibility for all activities that occur under your account or password. You may not assign or otherwise transfer your account to any other person or entity. You acknowledge that Mivera is not responsible for third party access to your account that results from theft or misappropriation of your account.

Mivera and its associates reserve the right to refuse or cancel service, terminate accounts, or remove or edit content in our sole discretion.

Your Account Types

Mivera offers personal accounts to individual members. Please note, not all Mivera features are available in all locations.

Children Under Thirteen

Mivera does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. At this time, we only accept members 18 and over.

Cancellation/Refund Policy

If a user is enrolled in a Service Plan, the user would be charged until the user cancels the Service Plan. All fees are non-refundable. Mivera reserves the right to change the fees for its Services from time to time. Users will be notified of any change to existing fees at least thirty (30) days before the fee change goes into effect. If a fee increase or change to this Agreement is not acceptable to the user, the user may cancel the Services as provided herein prior to the time when such fee increase or change to this Agreement takes effect. User's continued use of the Services beyond the cancellation window constitutes User's agreement to those changes.

Arbitration

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and Mivera agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
